Roll call showed the following members present: Supervisor Sanders, Clerk Schultz, Trustees Payson, Schuldt, Schultz and Swanson. Also present were Assessor Sires and Highway Commissioner Schultz.

Supervisor Sanders asked for a motion to open the Budget Hearing for the Town for the fiscal year ending March 31, 2013. **A motion was made by Trustee Payson and seconded by Trustee Swanson to open the Town Fund Budget Hearing for the fiscal year ending March 31, 2013. The total amount being proposed for the upcoming budget for the Town Fund is \$288,200.00. Out of this total amount is the assessors budget in the amount of \$132,500.00 and \$7,700.00 General Assistance Fund leaving a total for the Town in the amount of \$148,000.00.
