

**TAX LEVY ORDINANCE**  
**ROAD DISTRICT**  
**ORDINANCE No. RU 2021 - 04**

An ordinance levying taxes for all road purposes for RUTLAND Township Road District,  
KANE County, Illinois, for the tax year 2021, collectable in 2022.

BE IT ORDAINED by the Board of Trustees of RUTLAND Township, KANE County, Illinois,  
as follows:

SECTION 1: That the Highway Commissioner of RUTLAND Township Road District on  
December 14, 2021 does hereby determine and declare that the sum of Five hundred  
fifty-nine thousand one hundred thirty-two and no/100 Dollars (\$ 559,132.00 ) are  
hereby levied upon all property subject to taxation within the Road District as that  
property is assessed and equalized, in order to meet and defray all the necessary  
expenses and liabilities of the Road District as required by statute or voted by the people  
in accordance with the law, for such purposes as:

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Rutland Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.

ADOPTED this 14th day of December, 2021, pursuant to a roll call vote by the Board of Trustees of Rutland Township, Kane County, Illinois.

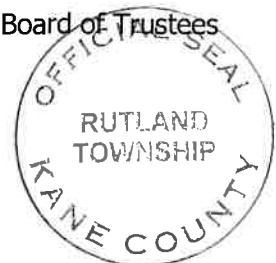
