OLD BUSINESS

Trustee J. Siers apprised the Board of her discussions with David Yee regarding the age of the current Township computer (Supervisor's – to be around 4 years) and his thoughts that the township could purchase a portable hard drive and offload non-essential documents and continue using the current computer, or purchase a new computer. He estimated the purchase cost for the new computer would be \$1200 - \$1400 including the necessary software. Discussion.

NEW BUSINESS

Discussion regarding Ordinance RU-2021-03 Township Levy Ordinance. Supervisor Lemus explained the levy amounts indicated. Trustee B. Siers spoke on the necessity of funding appropriately for the Building & Grounds, and reviewed the previous dialogue regarding repairs needing to be done on the salt shed to maintain the integrity of the shed. Discussion.

Discussion regarding Ordinance RU-2021-04 Road District Levy Ordinance. Commissioner Schultz presented his levy amounts. He then spoke about needing to purchase a new truck but not being able to proceed because of production problems associated with Covid. No dealerships will

guarantee delivery, costs have increased over 30% - trucks cannot be built and delivered within the same budget year.

Discussion regarding providing notary service to residents (by appointment) through the Township offices. Motion made by Trustee B. Siers to provide this service on a trial basis for one year and revisit after that time whether to continue the service. Second by Trustee D. Kenik. Vote: Roll call vote.

REPORTS BY OFFICIALS

Commissioner Schultz congratulated Trustee Alesi on his appointment and spoke about the TOKC Annual Dinner meeting. He also spoke about the County transportation meeting he and Trustee J. Siers attended, the specifics of the meeting and the lack of funding the township receives from impact fees for building in Rutland township. As per state statute, townships receive no monies from impact fees.

The State of Illinois (IDOT) is going to establish and build a bike path in from the DeKalb County line to Starks. The townships included in this endeavor are Hampshire and Rutland. The state will build the path but the townships will have to maintain the path. It is a 5-year project and will begin in 2022. Discussion continued regarding the expense and lack of input the township has, and will have on the project. Commissioner Schultz will contact the County and State for more information.

He also spoke on the necessity of budgeting/investing for future expenses of township buildings and grounds and how Trustee B. Siers has been the only person lobbying for that funding consistently through the years and how not levying for those expenses is short-sighted and increases costs.

Trustee Alesi suggested Commissioner Schultz contact IDOT and discuss IDOT's plan to allocate funds for maintenance and liability of the bike path.

Trustee J. Siers reported to the Board regarding the cost of the security system for the Township office, the garage and the Assessor's office and what changes can be made to reduce expenses. Options are available. Copies of the information were given to the Board for review and discussion at the December meeting.

Clerk Rendl reminded the Board about the TOI virtual conference November 15-17th; registrations are still being accepted.

Supervisor Lemus asked if there was any additional discussion.

There being none, **motion was made** by Trustee J. Siers; second by Trustee D. Kenik to adjourn the meeting.
