

**TAX LEVY ORDINANCE**

**ROAD DISTRICT**

**ORDINANCE No. RU-2022-03**

An ordinance levying taxes for all road purposes for RUTLAND Township Road District, KANE County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of RUTLAND Township, KANE County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of RUTLAND Township Road District on December 13, 2022 does hereby determine and declare that the sum of Five hundred fifty-nine thousand one hundred thirty-two and no/100 Dollars (\$ 559,132.00 ) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:
