TREASURER'S REPORT FYE 2019-2020 (TOWN AND ROAD DISTRICT FUNDS)

Recitation and explanation of the FYE 2019 – 2020 Treasurer's Report given by Supervisor Sanders.

REPORT BY HIGHWAY COMMISSIONER

Commissioner Schultz introduced himself and reported on the paving done in Rutland Township, the storm sewer work that was done in the township, the striping done on all the main roads, and tree trimming. He also informed the audience on the moving permit program and the income it produces (over \$100,000 that has gone back into the Township) that he initiated when he came into office. He then spoke about the utility permit program he initiated last year and the income it has produced (\$14,000.00); the permit income does not come from taxpayers but comes from contractors doing work in the Township. He also spoke on the toll the snow and most importantly, the salt has taken on equipment and roads which won't really be seen until the next few years. He then answered questions from the audience. Betty Kabance, 18N316 Powers Road, Nancy Reid, Powers Road and Bob Parks, 40W518 Freeman Road, all discussed the speeding on Powers and Freeman roads. Commissioner Schultz informed the audience on the county procedures in place regarding road signage and the difficulty the Township has with the State and County when trying to get signs installed. Discussion took place regarding the problems the Kane County Sheriff has trying to stop the speeding. Nancy Reid also spoke on the trash accumulation on Powers Road. She thanked Commissioner Schultz for the Road District's effort in trying to keep the garbage cleaned up.

REPORT BY ASSESSOR

Assessor Fritz introduced himself and reported on the commercial building taking place in the township, the EAV of the Township (\$3,000,000), property divisions and open permits for new construction. He also reported on the staffing, funding and activity of his office. He followed by withdrawing his IMRF agenda item in this meeting and answered questions from the audience.

REPORTS BY SUPERVISOR AND OR TRUSTEES

Supervisor Sanders asked for any questions on the report she gave earlier. No questions.

Trustee Keegan spoke on his history with the Township and then spoke on the gas main installation from Elgin through Pingree Grove to Hampshire and the experience of learning about the pipeline.

Commissioner Schultz spoke on the pipeline structure and how Rutland Township benefitted from the permits obtained for the work and moving that took place in the township; how the money from those permits went to paving and maintenance of the roads - money that taxpayers did not have to pay.

Supervisor Sanders then spoke on how careful this Board is regarding the responsibility of spending taxpayer monies.

Trustee Hoffman thanked the audience for participating in this meeting.

Deputy Clerk Siers reminded the audience about the April 6th election, early voting, the information about voting displayed on the Kane County website.

Moderator Schultz asked for questions or comments from the audience. No questions or comments.

Moderator Schultz then asked for a motion to adjourn.
