

TAX LEVY ORDINANCE
ROAD DISTRICT
ORDINANCE No. RU 2020 - 05

An ordinance levying taxes for all road purposes for RUTLAND Road District,
KANE County, Illinois, for the tax year 2020, collectable in 2021.

BE IT ORDAINED by the Board of Trustees of RUTLAND Township, KANE County,
Illinois, as follows:

SECTION 1: That the Highway Commissioner of RUTLAND Road District on December 8, 2020 does hereby determine and declare that the sum of Five hundred thirty-two thousand five hundred seven and no/100 Dollars (\$ 532,507.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
