Supervisor Sanders then went over the totals, with salaries in the amount of \$11,985.51 and invoices in the amount of \$12,523.93 for a total of \$24,509.44. With no further discussion a motion was made by Trustee Payson and seconded by Trustee Swanson to approve and authorize payment of the town bills in the amount \$24,509.44 as presented for the May 14, 2013 board meeting. Vote: Roll call vote.
