

**TAX LEVY ORDINANCE**

**TOWNSHIP**

**ORDINANCE No. RU 2021 - 03**

An ordinance levying taxes for all town purposes for   RUTLAND   Township,  
  KANE   County, Illinois, for the tax year 2021, collectible in 2022.

BE IT ORDAINED by the Board of Trustees of   RUTLAND   Township,  
  KANE   County, Illinois, as follows:

SECTION 1: That the sum of Three-hundred twenty-two thousand four hundred thirty six and no/100 Dollars (\$322,436) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:
