The Rutland Township Board held its regular monthly meeting in the town hall. Supervisor Bulmahn called the meeting to order at 7:00 p.m. and then asked Trustee Schuldt to lead us in the Pledge to the Flag. SUPERVISOR'S ANNOUNCEMENTS

The Supervisor hopes to keep the agenda moving tonight due to the large amount of business scheduled. We have both the town and road budget hearings in addition to the regular meeting so we need to keep things moving. That being said he asked Officer Grimes, from the Kane County Sheriffs Dept., for his report. Officer Grimes then submitted the monthly Township crime and accident reports and also brought gunlocks to be distributed for anyone interested. The Board thanked the Officer for coming and also for the locks. Supervisor Bulmahn reminded everyone that next months Board meeting will begin at 5:45 p.m. and asked the Clerk to remind the Trustees a day or two ahead of the meeting.

MINUTES

There were no additions or corrections to the February minutes so, a motion was made by Trustee Tessendorf and seconded by Trustee Brown to approve the minutes of February 12, 2008. Vote: Voice vote, all ayes. 2008-03-01 Motion carried.

FINANCIALS

The financial reports for the 10 months ending January 31st were distributed last month for the Boards consideration this month therefore, a motion was made by Trustee Tessendorf and seconded by Trustee Stelford to approve the financial reports for the ten months ending January 31, 2008. EMPLOYEE HEALTH BENEFIT ALTERNATIVES

Supervisor Bulmahn has received a flyer from Larry Holly, an insurance agent in Aurora, who also serves Campton and St. Charles Townships. He's spoken with him regarding the various alternatives and coverage's available for full time employees. Mr. Holly needs names, ages, and the type of coverage needed in order to give us a quote. The Supervisor has a couple of other leads but this one seems to be the most encouraging. Since the department heads have allocated line items in their upcoming fiscal year budgets the costs will have to be determined by those amounts. The goal is to have a couple of insurance proposals prior to next months meeting and to also have the Department Heads meet and come to the Board with a proposal at next months meeting.

A motion was then made by Trustee Brown and seconded by Trustee Tessendorf to suspend the Regular Board meeting at 7:15 p.m. in order to open the Budget Hearing for the Road District. Vote: Voice vote, all ayes. 2008-03-04 Motion carried.

The meeting was reconvened at 8:00 p.m. and began with a discussion on the sign proposal from Insignia Sign. This is for the sign being considered for the front of the township that's been discussed at previous Board meetings. It was suggested by resident Bill Siers that we check with the County Forest Preserve to see if they could make the sign as they make their own signs for the Forest Preserves. Supervisor Bulmahn will call them to see if they will and what the cost would be.

BILLS AND SALARIES

The Town bills were the next item on the agenda with salaries of \$11,586.58, prepaid bills of \$1,798.00, and unpaid bills of \$1,675.19 for total claims of \$15,059.77. There being no questions on the bills, **a motion was made by**

The Road District bills were then discussed with salaries of \$17,335.50, unpaid bills of \$14,671.07 and total claims of \$32,006.57. A fair amount of electrical work was needed on the garage due to inadequate wiring and the Road Commissioner hopes to do additional upgrading in the near future. Trustee Brown questioned the bill from the Kane County Division of Transportation and Commissioner Schultz explained those costs were for bridge inspections which are done every three to five years. There being no further questions, a motion was made by Trustee Brown and seconded by Trustee Tessendorf to approve the Road District bills for the month of February 2008 in the amount of \$32,006,57 as presented.
