The Rutland Township Board held its regular monthly meeting in the town hall. The Supervisor called the meeting to order at 7:00 p.m. and then asked Trustee Brown to lead us in the Pledge to the Flag. The Supervisor opened the meeting by thanking the veterans present tonight for their service to our country. Roll call showed the following members present: Supervisor Bulmahn, Clerk Carlsen, Trustees Brown, Schuldt, Tessendorf, & Stelford. Also present were Assessor Siers and later in the meeting Road Commissioner Schultz.

SUPERVISOR'S ANNOUNCEMENTS

Supervisor Bulmahn noted that the sign work is nearly complete and he will have a report for next months meeting of all costs incurred for it's construction. Prevailing wage rules do not apply to the sign's construction since Township employees did the work in house. We'll be receiving our last tax deposit from the county, plus any interest due, this month. The garage floor has been completed with only the roof venting to be done. Kane County will come out to inspect when it's completed. The main topic at next month's Board meeting will be the Levy.

MINUTES

There were no additions or amendments to the September minutes so, **a motion was made by Trustee Brown and seconded by Trustee Stelford to approve the minutes of the Board Meeting of October 14, 2008 as presented.** Vote: Voice vote, all ayes.

PRELIMINARY DISCUSSION ON PROPERTY TAX RATES FOR TOWN, ROAD & SOLID WASTE DISTRICT

This is a preliminary discussion on determining if we should stay within the 4.1% Kane County cap. Since we've managed our expenses well, within the cap, for the last couple of years as well as the state of the economy the Board agreed preliminarily to stay within the 4.1% cap. **A motion was made by Trustee Schuldt and seconded by Trustee Tessendorf to present our levy to Kane County under the 4.1% cap details of which will be presented to the Board next month.** Vote: Roll call vote.

RESOLUTION SETTING FORTH COMPENSATION RATES FOR ELECTED OFFICIALS (2009-2013)

There was much discussion by the Salary Committee as well as the Board on these salaries. The committee stands by all its previous recommendations, noted in the September & October minutes, and is firm in their decisions. Each salary was voted on separately beginning with the Trustees followed by the Supervisor, Clerk, Assessor and lastly the Road Commissioner. The Committee was asked to give their

recommendations first, to be followed by motions from the Board. The first committee recommendation was to retain the Trustee compensation at \$100.00 per meeting for the upcoming term. **A motion was made by Trustee Brown and seconded by Trustee Stelford to set the compensation for the Trustees for the next four years at \$100.00 per meeting.** Vote: Roll call vote.

The Supervisor recommended that the Supervisor's salary be fixed at \$21,000 (which includes the Treasurers salary of \$1,000) for 2 years, then increase to \$22,000 for the third year and remain at that level for the fourth year. The auto allowance will increase from \$576.00 to \$1,000.00 and to include cost of living annually. Following a lengthy discussion, **A motion was made by Trustee Schuldt and seconded by Trustee Brown to fix the Supervisor's salary (which includes the Road District Treasurer's salary of \$1,000) at \$21,000 for 2 years, then increase to \$22,000 for the third year and remain at that level for the fourth year. The auto allowance will increase from the current level of \$576.00 to \$1,000.00 and includes cost of living annually.** Vote: Roll call vote. 2 ayes, Trustees Schuldt & Supervisor Bulmahn with 3 nays by Trustees Tessendorf, Stelford & Brown, motion failed.

SECOND MOTION ON SUPERVISOR'S SALARY – A motion was made by Trustee Brown and seconded by Trustee Tessendorf that the Supervisor's salary be set at \$20,000 and \$1,000 for the Road District Treasurer with the existing auto allowance to remain at \$576.00 with both increasing by the annual cost of living tied to the Kane County CPI. Vote: Roll call vote, 3 ayes Trustees Brown, Tessendorf & Stelford with 2 nays Trustee Schuldt & Supervisor Bulmahn, motion carried.

The Committee recommends that the Clerk salary remain at the current level of \$10,000 annually with the auto allowance remaining at \$576.00 annually with both to

receive an annual cost of living adjustment per Kane County CPI. Much discussion followed and then, **a motion was made by Trustee Brown and seconded by Trustee Tessendorf that the Clerk's salary remain at the current level of \$10,000 with the auto allowance also remaining at \$576.00 with both to receive an annual cost of living adjustment per Kane County CPI.** Vote: Roll call vote, 3 ayes, Trustees Brown, Tessendorf, & Stelford. 2 Nays Trustee Schuldt and Supervisor Bulmahn, motion carried.

The Committee recommends that the Assessor's salary be set at \$34,500 with an annual cost of living increase and the existing auto allowance of \$1,440 to be adjusted for cost of living annually as well. Much discussion ensued followed by **a motion made by Trustee Brown and seconded by Trustee Tessendorf that the Assessor's salary be set at \$34,500 with a cost of living increase annually from Kane County CPI with the existing auto allowance of \$1,440 to be adjusted by CPI as well.** Vote: Roll call vote, 2 ayes Trustees Brown & Tessendorf 3 nays, Trustees Schuldt & Stelford & Supervisor Bulmahn, motion failed.

SECOND MOTION ON ASSESSOR'S SALARY – A motion was made by Trustee Schuldt and seconded by Trustee Stelford to start the Assessor's salary at \$38,000 with an increase of \$1,000 per year. The existing auto allowance of \$1,440 to have an annual cost of living increase per Kane County CPI. Vote: Roll call vote, 3 ayes, Trustees Schuldt & Stelford, and Supervisor Bulmahn. 2 nays Trustees Tessendorf & Brown, motion carried.

The Committee recommends that the Road Commissioner's salary be set at the current level of \$30,000 annually with an annual auto allowance of \$500 both to include annual cost of living adjustments. A Discussion then followed and **a motion was made by Trustee Brown and seconded by Trustee Tessendorf to set the Road Commissioner's salary at the current level of \$30,000 plus an annual auto allowance of \$500.00 both to be adjusted annually for cost of living per Kane County CPI.** Vote: Roll call vote, 2 ayes, Trustees Brown & Tessendorf with 3 nays Trustees Stelford & Schuldt & Supervisor Bulmahn. Motion failed.

SECOND MOTION ON ROAD COMMISSIONER'S SALARY – **A motion was made by Trustee Schuldt and seconded by Trustee Stelford to raise the salary of the Road Commissioner to \$34,000 to start with increases of \$1,000 per year for the next 3 years plus an annual auto allowance of \$2,000 plus a cost of living annually.** Vote: Roll call vote 3 ayes, Trustees Schuldt & Stelford & Supervisor Bulmahn with 2 nays Trustees Tessorf & Brown. Motion carried.

The Supervisor thanked the Salary Committee, Trustees Brown and Tessorf, for their hard work.

REPORTS BY OFFICIALS

The Clerk noted that Election Day was a disaster here at the Township Hall. Hundreds of people came here to vote only to find that they needed to go either to the Eagles Club in Gilberts or to Del Webb in Huntley. Everyone who came said that they had not been notified of any change in their polling place. The County had sent us a sign to post on the front door sending everyone to the Eagles but many were turned away and told they couldn't vote there. Hopefully this will all be straightened out by the April election. Packets are also available for anyone wanting to run for any of the Township positions and petitions may be circulated as of Oct. 28th. They need to be turned in to me by January 26, 2009 along with the Statement of Economic Interest receipt from the County.

The Road Commissioner reported that the caps for the sign pillars are yet to be installed and that he had no man-hours report.

Assessor Siers presented a letter to the Board from Kane County that might be helpful with regard to an issue that came up at last months meeting. Property assessments are out and her office is receiving several calls per day as people are having trouble understanding them.

ADJOURN

There being no further business, **a motion was made by Trustee Schuldt and seconded by Trustee Brown to adjourn the November meeting at 9:00 p.m.** Vote: Voice vote, all ayes, motion carried.
