REPORTS BY OFFICIALS

Commissioner Schultz discussed the traffic analysis report provided in the Public Hearing held just previous to this meeting and the reality of the speeding and traffic issues on Powers and Freeman roads and the issues regarding the semi-trucks on these roads and the destruction taking place, i.e., the necessity for reducing the weight limit on those roads. He also discussed the paving contract changes this year (J.A. Johnson) and the current asphalt plant strike that is affecting the paving scheduled for the Township. He stated that Mark Schuster's help in the weight limit reduction process was invaluable. Discussion also took place regarding the Speeding the speeding/traffic problems on these roads but the non-resident business and truck traffic.

Assessor Fritz stated that the industrial is "booming" in Rutland Township and reviewed the current and projected construction taking place in the Township. He discussed the increases in purchase prices of housing in the Township and how those sales are increasing the valuations in Rutland Township resulting in increased taxes. He also stated that his office will be issuing reductions for the residential properties associated with Freeman and Powers roads resultant of the commercial traffic issues.

Trustee J. Siers requested permission to continue cleaning tombstones in the cemetery on Square Barn Road. Permission granted.
