Discussion continued on the invoice for the Village of Gilberts, which is payment for the crack filler that we share a bill on. This is done in the fall. With no further discussion a motion was made by Trustee Payson and seconded by Trustee Swanson to authorize payment of the July bills for the Road District in the amount of \$122,888.00 as presented for the August 2010 meeting.
