Supervisor Bulmahn also announced that our meeting before the Kane County Zoning Board for our proposed sign is scheduled for August 28th at 7:00 p.m. We are requesting a variance of our setback that is 15 ft. closer to Big Timber then the County specifies in their ordinances. There has been some recent publicity about concerns for our Bank, National City, so we've asked them to increase the collateral another \$200,000.00 and have moved some of the road fund money over to the Illinois Funds.
