Presentation and discussion on the May 31, 2015 financial statements followed. Trustee Bulmahn then questioned the Assessor about the Legal line item in her budget when it was previously determined by

the Township attorney to be unnecessary since the Town budget already covers that expense. Further discussion followed with the Assessor and **A motion was made by Trustee Bulmahn and seconded by Trustee Payson to change the name of the line item in the Assessors budget.** After some further discussion the motion was tabled till next months meeting. It was stated that if the line item were changed then the two months following would need to be changed as well. The May, 2015 Road district financials were also presented for the Board to consider and vote on next month.

BILLS AND SALARIES

Discussion on the Town fund bills began with salaries of for the month of May at \$16,710.73, unpaid bills of \$9,483.19, auto payments of \$797.00 & QuickBooks charges of \$120.10 for a total of \$27,111.02. Following some questions on the legal bills the Ansel Glink invoices were deducted thereby changing the total amount of the bills to be paid to \$26,961.02. **A Motion was then made by Trustee Payson and seconded by Trustee Bulmahn to approve the Town fund bills and salaries in the amount of \$26,961.02.** Roll call vote: 2015-06-07

Trustee Bulmahn thanked all the candidates for applying and acknowledged their qualifications. He then nominated Thomas Ray Eaton noting his community involvement as well the fact that being from Pingree Grove the Board will then have representation from all the villages within the Township. **A motion was then made by Trustee Bulmahn and seconded by Trustee Schuldt to appoint Thomas Ray Eaton as Trustee.** Trustee Schuldt acknowledged
