TAX LEVIES FOR 2009 TAXES COLLECTIBLE IN 2010

A complete set of documents including the Levy Certification of Compliance, the Levy Summary, the Levy Ordinance and Summary with a preliminary budget detail has been included in the Trustees note books this month. The levies for the Town provide for a 4.9% increase which falls under the 5%, Cap set by the County. There being no questions or comments, a motion was made by Trustee Schuldt and seconded by Trustee Whalen to approve Ordinance #RU2009-08 being the Tax Levy Ordinance for the Rutland Township Town Fund for the property tax year 2009 to be collectible in the calendar year 2010. This to be broken down between the General Town Fund of \$257,600.00, the General Assistance Fund of \$4,400.00 for a total Levy of \$262,000.00 with details attached. Vote: Roll call vote.

A motion was then made by Trustee Whalen and seconded by Trustee Swanson to approve Ordinance #RU2009-10 being the Tax Levy Ordinance for the Rutland Township Road district in the amount of \$451,000.00. Broken down between the permanent Road Fund of \$429,000.00, the General Road and Bridge Fund of 5,000.00, and the Equipment and Building Fund of \$17,000.00 for a total of \$451,000.00 all being within the 5% Cap set by the county. Vote: Roll call vote.
