# **RESOLUTION TO APPROVE AUDITORS FOR FYE MARCH 31, 2010**

The proposed cost by auditors Tighe, Kress & Orr CPA's in Elgin is \$6,650.00 to perform the audit for this fiscal year. Though this is an increase over last year the supervisor would like for them to do the audit as they are familiar with our township. The Trustees would like for us to counter offer with them for a lower price or last year's rate. If they do not want to do that we will work from there. The resolution has been tabled until next month.

### PRELIMINARY DISCUSSION ON PROPERTY TAX RATES FOR TOWN, ROAD & SOLID WASTE DISTRICT

This is a preliminary discussion on determining if we should stay under the 5.0% Kane County cap. Supervisor Sanders stated that in order to have enough funds to operate the town that the town will levy at the 4.9%. That would give the town enough funds to operate. This is also the same with the Road District. The Road District will also stay under the 5.0% cap with a levy at 4.5% at this time. The Assessor will give her more information next month.

### **IMRF**

With the discussions the last couple of months on IMRF, a letter received by our town attorney stated that it is not an option at this time to consider the program, it is part of the official's compensation and that it can not be changed because compensation for the new officials was all ready set in 2008 for the 2009 election. It can be discussed in the year of 2012 for the next Township Election in 2013.

# OTHER BUSINESS MATTERS

Rutland Township Food Pantry Request. We do not have one at this time. Discussion continued on where we could direct residents if we get requests on this issue.

The Historical society meet here in October it was a grand meeting and they suggested the township purchase The Historical Society Family Maps of Kane County, the book costs \$36.95 and it is full of maps and family names of Kane County. It was agreed that we should have one copy in house for residents. A motion was made by Trustee Swanson and seconded by Trustee Whalen to purchase the book, The Historical Society Family Maps of Kane County.
